Dear Parents,

As Superintendent of the San Mateo-Foster City School District I've had the pleasure of writing to you over the year(s) about the outstanding achievements at our local schools. The success of our schools is the result of many factors, including our outstanding teachers and staff, challenging programs, dedicated parents and strong support for our schools from the community. Unfortunately, I now have to write to you about some significant challenges we face.

Historically, the revenue that pays for general education has come from local property taxes and the State. As you have no doubt heard, the State has cut education funding by unprecedented amounts and these funding reductions are expected to continue for the foreseeable future. These drastic state funding reductions have forced San Mateo-Foster City schools to cut more than \$18 million from its budget to date, with more cuts on the horizon. In fact, State revenues have been reduced so significantly that it appears this year, we will be solely funded by our local property taxes, and receive no State revenues.

Additionally, funding from our local school parcel tax is set to expire in June 2010. The parcel tax, which was approved by over 70% of local voters seven years ago, currently provides nearly \$3 million in stable local funding each year that cannot be taken away by the State. If the parcel tax is not renewed, we will have to cut an additional \$3 million on top of the \$18 million in state funding cuts.

Our local elementary and middle schools cannot absorb such deep cuts without a severe reduction in the quality of education.

At their meeting on November 19, the Board of Trustees voted unanimously to place a measure on the ballot next year that would renew the existing parcel tax for another seven years and increase the rate by \$96 (\$8 per month). These funds will be used to offset damaging state budget cuts and preserve the quality of education in our local schools by:

- ✓ Attracting and retaining qualified teachers and staff
- ✓ Maintaining school libraries
- ✓ Providing middle school art and music programs
- ✓ Supporting small class sizes
- ✓ Supporting programs which enhance student achievement

Senior citizens would continue to be eligible for an exemption to ensure the cost is not a burden to those living on a fixed income. Independent oversight of parcel tax funds will continue to ensure they are spent as promised. All money from a parcel tax stays here in our school district and cannot be taken away by the State.

This measure will be decided by a special mail-in ballot election in February 2010. There will be no polling places for this election. All registered voters will receive a ballot in the mail the week of January 25, 2010 and ballots will be due by February 23, 2010.
