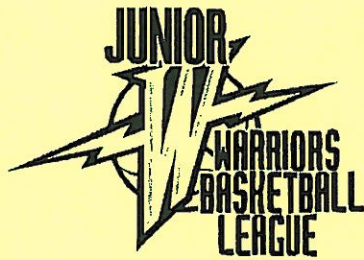


Peninsula Family YMCA Presents
